Short Term Care Is Available at Pediatric Skilled Nursing Facilities

The Need for Care



Today there are many innovative surgeries and treatments to address the unique needs of children with complex medical conditions.

Until recently there have been few options for skilled nursing care following

procedures such as spinal fusion, intense respiratory therapy or G-tube placement. Medically fragile children have had to endure extended hospital stays until they have recovered sufficiently or be released to caregivers who can be overwhelmed by their intense needs during recovery.

Massachusetts recently established an expedited evaluation and approval process that allows hospitalized children to transfer to pediatric skilled nursing facilities designed just for children for up to 90 days.

New England Pediatric Care, an 80-bed skilled nursing facility for children, has been approved to provide interim care.

Applications for interim placement must be approved by the State's Medical Review Team while the child is still hospitalized. Most will be approved within 24-36 hours.

New England Pediatric Care has full access to the doctors and expertise of Boston Floating Hospital for Children and Tufts Medical Center.

NEPC Services

Our dedicated team of professionals will work directly with referring hospitals, families and providers to determine whether we can meet a child's needs. Depending on his/her needs, each admitted child, has access to:

- 24-hour skilled nursing & personal care
- On-site clinics which can include rehabilitation, pulmonary, orthopedic, brace, wheelchair, optometry & dental
- Adaptive recreational programs
- Fully-accredited special needs day school



NEPC is a family-centered environment where families are welcome 24 hours a day. Parents and guardians can participate in their child's daily life to whatever extent they are able. They continue to be the sole decision makers

regarding any medical or educational plans developed for their child.

Who is Eligible?

To be considered for short term care, each child must:

- Require skilled nursing care
- Be hospitalized and recommended for discharge
- Be ages *birth* up to *22 years old*
- Have a definite plan in place to return to the family home or a community placement

Children of all cognitive and developmental levels are eligible.

Sample Admissions

- **Orthopedic surgery** – when school/home services need to be augmented for a short time
- **GI surgery** – G/J-Tube placement, fundoplication, bowel surgery, etc.
- **After care requiring intense respiratory or IV therapy**
- **Trach placement**
- **Non-weanable ventilator dependency requiring intense home teaching**
- **Any hospitalization where home teaching is indicated**
- **NICU transition/teaching** for family or identified foster placement
